Collectively referred to as the "Parties" and individually as a "Party."

#### Preamble:

Party B, through her company A Wish Link, offers services in wellness coaching, personal development, yoga, and retreats. Party A wishes to recommend clients for these services and formalize this collaboration within the framework of this referral agreement.

# Article 1: Purpose of the Contract

This contract aims to define the conditions under which Party A recommends clients for wellness coaching, yoga, and retreats offered by Party B through A Wish Link.

#### Article 2: Commission

In exchange for the referrals made by Party A, Party B agrees to pay a commission of 10% (exclusive of tax) on the invoiced amount for each transaction concluded thanks to Party A's recommendations. The commission can take the form of:

- A discount on services offered by A Wish Link,
- A discount coupon,
- Free services, or
- Cashback.

The form of this commission will be determined on a case-by-case basis, according to Party A's choice.



# REFERRAL AGREEMENT

## **Article 3: Payment Terms**

The commission will be paid quarterly, on the first day of each quarter, by bank transfer or in another form chosen by Party A, in accordance with Article 2. A summary of the amounts due will be sent by email one week before each payment date. A payment confirmation will be sent by email once the transfer has been made or the discount has been applied.

#### **Article 4: Duration of the Contract**

This contract is concluded for an indefinite period. Each Party may terminate it at any time with three (3) months' notice, by registered letter with acknowledgment of receipt.

# **Article 5: Confidentiality and Transparency**

The Parties agree on the importance of honest and transparent communication regarding client referrals. To facilitate the traceability of referrals, each referred client may be assigned a unique referral code.

### **Article 6: Yoga Classes and Retreats**

For yoga classes and retreats organized by Party B through A Wish Link: If a client referred by Party A participates in a class or retreat, Party A will receive the usual 10% commission on the invoiced amount for the service, according to the terms of Article 2.

#### Article 7: Contract Modifications

Any changes to the terms of this contract must be made through a written amendment signed by both Parties.

## **Article 8: Disputes**

In the event of a dispute relating to the interpretation or execution of this contract, the Parties agree to attempt to find an amicable solution. Failing an amicable agreement, the dispute will be submitted to the competent courts of Party B's residence.
